BAC Resolution No. 2024-3Q-09- 1120

A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO THESSON'S MARKETING FOR THE SUPPLY & DELIVERY OF CANNED GOODS FOR CSWDO STOCKPILING, CDRRMO, TABACO CITY UNDER CONTRACT ID NO. 026-07-2024-GOODS-PB-R1

WHEREAS, the City Government of Tabaco posted the Invitation to Bid for the *Supply & Delivery of Canned Goods for CSWDO Stockpiling, CDRRMO, Tabaco City under Contract ID No. 026-07-2024-GOODS-PB-R1*, with an Approved Budget for the Contract (ABC) amounting to *One Million Ninety-Eight Thousand Nine Hundred Ninety-Two Pesos (Php 1,098,992.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, one (1) supplier had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission and opening of bids on September 10, 2024, the BAC received one (1) bid proposal;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary "pass/fail" criteria, resulted as follows, to wit:

WHEREAS, the BAC immediately conducted the detailed evaluation of bid, which resulted as follows, to wit:



WHEREAS, the BAC Technical Working Group (TWG) conducted the post-qualification of *Thesson's Marketing*, the bidder with single calculated bid, involving the verification and validation of its legal, technical and financial documents. It was found that *Thesson's Marketing* is substantially compliant with the requirements of the foregoing procurement and its bid is responsive;

NOW, THEREFORE, for and in consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To declare the bid of *THESSON'S MARKETING* as the Single Calculated Responsive Bid (SCRB) for the *Supply & Delivery of Canned Goods for CSWDO Stockpiling, CDRRMO, Tabaco City under Contract ID No. 026-07-2024-GOODS-PB-R1*; and
- b) To recommend to the City Mayor of Tabaco the award of contract to *THESSON'S MARKETING* in the amount of *One Million Ninety-Eight Thousand Nine Hundred Ninety-Two Pesos (Php 1,098,992.00)*.


