A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO LEGAZPI PREMIUM DEVELOPMENT CORPORATION FOR THE JO-SUPPLY OF LABOR AND MATERIALS FOR THE INSTALLATION OF POWER AND ENERGY SUPPLY OF WATER DESALINATION TREATMENT FACILITY AT BRGY. HACIENDA, SAN MIGUEL ISLAND, TABACO CITY
