BAC Resolution No. 2024-4Q-10- 1245

A RESOLUTION DECLARING THE LOWEST CALCULATED RESPONSIVE BID (LCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO ALBAY COMPUTER & ELECTRONICS SUPPLIES & REPAIRS FOR THE SUPPLY & DELIVERY OF I.T. EQUIPMENT FOR VARIOUS OFFICES, TABACO CITY UNDER CONTRACT ID NO. 022-07-2024-GOODS-PB-R1

WHEREAS, the Local Government Unit of Tabaco City posted the Invitation to Bid for the *Supply & Delivery of I.T. Equipment for Various Offices, Tabaco City under Contract ID No. 022-07-2024-GOODS-PB-R1*, with an Approved Budget for the Contract (ABC) amounting to *One Million Six Hundred Eighty-Five Thousand Pesos (Php 1,685,000.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, two (2) suppliers had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission and opening of bids on October 01, 2024, the BAC received two (2) bid proposals;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary "pass/fail" criteria, resulted as follows, to wit:

WHEREAS, the BAC immediately conducted the detailed evaluation of bid, which resulted as follows, to wit:

WHEREAS, the BAC Technical Working Group (TWG) conducted a post-qualification of *Albay Computer & Electronics Supplies & Repair*, the bidder with lowest calculated bid, involving the verification and validation of its legal, technical and financial documents. It was found that *Albay Computer & Electronics Supplies & Repair* is substantially compliant with the requirements of the foregoing procurement and its bid is responsive;

NOW, THEREFORE, for and in consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To declare the bid of **ALBAY COMPUTER & ELECTRONICS SUPPLIES & REPAIR** as the Lowest Calculated Responsive Bid (LCRB) for the *Supply & Delivery of I.T. Equipment for Various Offices, Tabaco City under Contract ID No. 022-07-2024-GOODS-PB-R1*; and


