**A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO ALBAY COMPUTER & ELECTRONICS SUPPLIES & REPAIRS FOR THE SUPPLY & DELIVERY OF I.T. SUPPLIES AND EQUIPMENT FOR EXECUTIVE DEPARTMENTS, TABACO CITY UNDER CONTRACT ID NO. 033-09-2024-GOODS-PB**

**WHEREAS**, the Local Government Unit of Tabaco City posted the Invitation to Bid for the *Supply & Delivery of I.T. Supplies and Equipment for Executive Departments, Tabaco City under Contract ID No. 033-09-2024-GOODS-PB*, with an Approved Budget for the Contract (ABC) amounting to *One Million Three Hundred Fifty Thousand One Hundred Sixty Pesos and Ninety Centavos (Php 1,350,160.90)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

**WHEREAS**, in response to the said posting, one (1) supplier had shown interest to participate by purchasing the bidding documents;

**WHEREAS**, during the deadline for submission and opening of bids on October 03, 2024, the BAC received one (1) bid proposal;

**WHEREAS**, the opening and preliminary examination of bids, using non-discretionary "pass/fail" criteria, resulted as follows, to wit:



It was found that *Albay Computer & Electronics Supplies & Repair* is substantially compliant with the requirements of the foregoing procurement and its bid is responsive;

**NOW, THEREFORE**, for and in consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- To declare the bid of *ALBAY COMPUTER & ELECTRONICS SUPPLIES & REPAIR* as the Lowest Calculated Responsive Bid (LCRB) for the *Supply & Delivery of I.T. Supplies and Equipment for Executive Departments, Tabaco City under Contract ID No. 033-09-2024-GOODS-PB*; and
- To recommend to the City Mayor of Tabaco the award of contract to *ALBAY COMPUTER & ELECTRONICS SUPPLIES & REPAIR* in the amount of *One Million Three Hundred Eighteen Thousand Eight Hundred Sixty-Four Pesos (Php 1,318,864.00)*.


