A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO JAC AUTOMOBILE INT'L PHILS., INC. FOR THE SUPPLY & DELIVERY OF ONE UNIT BRAND NEW 6-WHEELER GARBAGE DUMP TRUCK, CENRO, TABACO CITY UNDER CONTRACT ID NO. 035-09-2024-GOODS-PB

WHEREAS, the City Government of Tabaco posted the Invitation to Bid for the *Supply & Delivery of One Unit Brand New 6-Wheeler Garbage Dump Truck, CENRO, Tabaco City under Contract ID No. 035-09-2024-GOODS-PB*, with an Approved Budget for the Contract (ABC) amounting to *Three Million Five Hundred Thousand Pesos (Php 3,500,000.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, one (1) supplier had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission and opening of bids on October 09, 2024, the BAC received one (1) bid proposal;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary "pass/fail" criteria, resulted as follows, to wit:

It was found that *JAC Automobile Int'l Phils., Inc.* is substantially compliant with the requirements of the foregoing procurement and its bid is responsive;

NOW, THEREFORE, for and in consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To declare the bid of *JAC AUTOMOBILE INT'L PHILS., INC.* as the Single Calculated Responsive Bid (SCRB) for the *Supply & Delivery of One Unit Brand New 6-Wheeler Garbage Dump Truck, CENRO, Tabaco City under Contract ID No. 035-09-2024-GOODS-PB*; and
- b) To recommend to the City Mayor of Tabaco the award of contract to *JAC AUTOMOBILE INT'L PHILS., INC.* in the amount of *Three Million Four Hundred Eighty-Eight Thousand Pesos (Php 3,488,000.00)*.


