BAC Resolution No. 2024-4Q-11- 1459

A RESOLUTION DECLARING THE LOWEST CALCULATED RESPONSIVE BID (LCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO BCVR PRIME ENTERPRISE FOR THE SUPPLY & DELIVERY OF DRUGS & MEDICINES, FWK AND MCK, TABACO CITY UNDER CONTRACT ID NO. 030-08-2024-GOODS-PB-R1.

WHEREAS, the Local Government Unit of Tabaco City posted the Invitation to Bid for the *Supply & Delivery of Drugs & Medicines FWK and MCK, Tabaco City under Contract ID No. 030-08-2024-GOODS-PB-R1*, with an Approved Budget for the Contract (ABC) amounting to *Seven Hundred Thirty-Nine Thousand Three Hundred Ninety-One Pesos and Eighty-Five Centavos (Php 739,391.85)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, two (2) suppliers had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission and opening of bids on November 11, 2024, the BAC received two (2) bid proposals;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary “pass/fail” criteria, resulted as follows, to wit:

WHEREAS, the BAC immediately conducted the detailed evaluation of bid, which resulted as follows, to wit:



WHEREAS, the BAC Technical Working Group (TWG) conducted a post-qualification of *BCVR Prime Enterprise*, the bidder with lowest calculated bid, involving the verification and validation of its legal, technical and financial documents. It was found that *BCVR Prime Enterprise*. is substantially compliant with the requirements of the foregoing procurement and its bid is responsive;

NOW, THEREFORE, for and in consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- To declare the bid of *BCVR PRIME ENTERPRISE* as the Lowest Calculated Responsive Bid (LCRB) for the *Supply & Delivery of Drugs & Medicines FWK and MCK, Tabaco City, Contract ID No. 030-08-2024-GOODS-PB-R1*; and
- To recommend to the City Mayor of Tabaco the award of contract to *BCVR PRIME ENTERPRISE*. in the amount of *Six Hundred Thirteen Thousand Five Hundred Thirty-Five Pesos and Twenty-Nine Centavos (Php 613,535.29)*.




