**BAC RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO CEBU 7H TECHNOCHEM INDUSTRIES, INC. THE NEGOTIATED PROCUREMENT (ADJACENT/CONTIGUOUS CONTRACT) OF THE PROJECT REHABILITATION / IMPROVEMENT OF "AA" SLAUGHTERHOUSE AT BRGY. SAN CARLOS, TABACO CITY, CONTRACT ID NO. 039-10-2024-INFRA-NP-A/C.**

**WHEREAS**, the Bids and Awards Committee (BAC) has adopted **Negotiated Procurement (Adjacent/Contiguous Contract)** as the mode of procurement for the project **Rehabilitation / Improvement of "AA" Slaughterhouse at Brgy. San Carlos, Tabaco City, Contract ID No. 039-10-2024-INFRA-NP-A/C** under **Purchase Request No. 24-10-1357** with an Approved Budget for the Contract (ABC) amounting to **Five Million Pesos (Php 5,000,000.00)**;

**WHEREAS**, the BAC directly negotiated with **Cebu 7H Technochem Industries, Inc.**, the contractor for the ongoing contract **Improvement/Rehabilitation of AA Slaughterhouse, ID No. PRDP-IB-R005-ALB-016-TAB-002-2020-AF2-R1** which is adjacent or contiguous to the foregoing contract;

**WHEREAS**, **Cebu 7H Technochem Industries, Inc.** had accepted the negotiation and offered to execute and complete the project at a contract price amounting to **Four Million Nine Hundred Ninety-Eight Thousand Seven Hundred Eighty-One Pesos and Fifty-Five Centavos (Php 4,998,781.55)**;

**WHEREAS**, upon detailed evaluation of its bid, the BAC found that the contractor used the same prices or lower unit prices as in the original contract;

**WHEREAS**, upon ascertainment of compliance with the requirements of the project, the BAC find the offer of **Cebu 7H Technochem Industries, Inc.** to be responsive and the most advantageous price to the government;






