BAC Resolution No. 2024-4Q-11- 1447

A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO 3RB CONSTRUCTION & SUPPLY FOR THE JOB ORDER: FABRICATION OF 60 UNITS CANOPY TENT, CITY ENGINEERING OFFICE, TABACO CITY UNDER CONTRACT ID NO. 043-10-2024-GOODS-PB.

WHEREAS, the Local Government Unit of Tabaco City posted the Invitation to Bid for the *Job Order: Fabrication of 60 Units Canopy Tent, City Engineering Office, Tabaco City under Contract ID No. 043-10-2024-GOODS-PB*, with an Approved Budget for the Contract (ABC) amounting to *Two Million Ninety-Nine Thousand Six Hundred Sixty-Four Pesos (Php 2,099,664.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, one (1) supplier had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission and opening of bids on November 11, 2024, the BAC received one (1) bid proposal;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary “pass/fail” criteria, resulted as follows, to wit:

- To declare the bid of **3RB CONSTRUCTION & SUPPLY** as the Single Calculated Responsive Bid (SCRB) for the *Job Order: Fabrication of 60 Units Canopy Tent, City Engineering Office, Tabaco City under Contract ID No. 043-10-2024-GOODS-PB*; and
- To recommend to the City Mayor of Tabaco the award of contract to **3RB CONSTRUCTION & SUPPLY** in the amount of *Two Million Seventy-Eight Thousand Four Hundred Pesos (Php 2,078,400.00)*.


