BAC Resolution No. 2024-4Q-11- 1396

A RESOLUTION DECLARING THE LOWEST CALCULATED RESPONSIVE BID (LCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO CLIKZ COMPUTER & CCTV FOR THE JOB ORDER: LABOR & MATERIALS FOR THE INSTALLATION OF CCTV CAMERAS, VARIOUS BARANGAYS, TABACO CITY UNDER CONTRACT ID NO. 044-10-2024-GOODS-PB.

WHEREAS, the Local Government Unit of Tabaco City posted the Invitation to Bid for the *Job Order: Labor & Materials for the Installation of CCTV Cameras, Various Barangays, Tabaco City under Contract ID No. 044-10-2024-GOODS-PB*, with an Approved Budget for the Contract (ABC) amounting to *Eight Hundred Thousand Pesos (Php 800,00.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, two (2) suppliers had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission and opening of bids on October 31, 2024, the BAC received two (2) bid proposals;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary "pass/fail" criteria, resulted as follows, to wit:

WHEREAS, the BAC immediately conducted the detailed evaluation of bid, which resulted as follows, to wit:



WHEREAS, the BAC Technical Working Group (TWG) conducted a post-qualification of *Clikz Computer & CCTV*, the bidder with lowest calculated bid, involving the verification and validation of its legal, technical and financial documents. It was found that *Clikz Computer & CCTV* is substantially compliant with the requirements of the foregoing procurement and its bid is responsive;

NOW, THEREFORE, for and in consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- To declare the bid of **CLIKZ COMPUTER & CCTV** as the Lowest Calculated Responsive Bid (LCRB) for the *Job Order: Labor & Materials for the Installation of CCTV Cameras, Various Barangays, Tabaco City under Contract ID No. 044-10-2024-GOODS-PB*; and
- To recommend to the City Mayor of Tabaco the award of contract to **CLIKZ COMPUTER & CCTV** in the amount of *Seven Hundred Thirty-Five Thousand Pesos (Php 735,000.00)*.


