BAC Resolution No. 2024-4Q-11- 1460

A RESOLUTION DECLARING THE LOWEST CALCULATED RESPONSIVE BID (LCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO PIXEL8 WEB SOLUTIONS AND CONSULTANCY INC. FOR THE JOB ORDER: LABOR & MATERIALS FOR THE REHABILITATION AND UPGRADING OF COMMUNICATION NETWORKS OF THE TABACO CITY HALL ANNEX BUILDING, TABACO CITY UNDER CONTRACT ID NO. 045-10-2024-GOODS-PB.

WHEREAS, the Local Government Unit of Tabaco City posted the Invitation to Bid for the *Job Order: Labor & Materials for the Rehabilitation and Upgrading of Communication Networks of the Tabaco City Hall Annex Building, Tabaco City under Contract ID No. 045-10-2024-GOODS-PB* with an Approved Budget for the Contract (ABC) amounting to *One Million Pesos (Php 1,000,000.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, two (2) suppliers had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission and opening of bids on November 11, 2024, the BAC received two (2) bid proposals;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary “pass/fail” criteria, resulted as follows, to wit:

WHEREAS, the BAC immediately conducted the detailed evaluation of bid, which resulted as follows, to wit:

WHEREAS, the BAC Technical Working Group (TWG) conducted a post-qualification of *Pixel8 Web Solutions and Consultancy Inc.*, the bidder with lowest calculated bid, involving the verification and validation of its legal, technical and financial documents. It was found that *Pixel8 Web Solutions and Consultancy Inc.* is substantially compliant with the requirements of the foregoing procurement and its bid is responsive;



- a) To declare the bid of *PIXEL8 WEB SOLUTIONS AND CONSULTANCY INC.* as the Lowest Calculated Responsive Bid (LCRB) for the *Job Order: Labor & Materials for the Rehabilitation and Upgrading of Communication Networks of the Tabaco City Hall Annex Building, Tabaco City, under Contract ID No. 045-10-2024-Goods-PB.*; and

- b) To recommend to the City Mayor of Tabaco the award of contract to **PIXEL8 WEB SOLUTIONS AND CONSULTANCY INC.** in the amount of **Eight Hundred Thirty-Two Thousand Nine Hundred Fifty-Six Pesos (Php 832,956.00).**


