BAC Resolution No. 2024-4Q-11- 1449

**A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO FOODSPHERE, INC. FOR THE SUPPLY & DELIVERY OF GROCERY ITEMS FOR THE PAMASKONG HANDOG 2024, CITY MAYOR'S OFFICE, TABACO CITY UNDER CONTRACT ID NO. 041-10-2024-GOODS-PB.**

**WHEREAS**, the Local Government Unit of Tabaco City posted the Invitation to Bid for the *Supply & Delivery of Grocery Items for the Pamaskong Handog 2024, City Mayor's Office, Tabaco City under Contract ID No. 041-10-2024-GOODS-PB*, with an Approved Budget for the Contract (ABC) amounting to *Sixteen Million Eight Hundred Seventy-Four Thousand Five Hundred Pesos (Php 16,874,500.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

**WHEREAS**, in response to the said posting, one (1) supplier had shown interest to participate by purchasing the bidding documents;

**WHEREAS**, during the deadline for submission and opening of bids on November 11, 2024, the BAC received one (1) bid proposal;

**WHEREAS**, the opening and preliminary examination of bids, using non-discretionary "pass/fail" criteria, resulted as follows, to wit:

**WHEREAS**, the BAC immediately conducted the detailed evaluation of bid, which resulted as follows, to wit:



**WHEREAS**, the BAC Technical Working Group (TWG) conducted a post-qualification of *Foodsphere, Inc.*, the bidder with single calculated bid, involving the verification and validation of its legal, technical and financial documents. It was found that *Foodsphere, Inc.* is substantially compliant with the requirements of the foregoing procurement and its bid is responsive;

**NOW, THEREFORE**, for and in consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To declare the bid of *FOODSPHERE, INC.* as the Single Calculated Responsive Bid (SCRB) for the *Supply & Delivery of Grocery Items for the Pamaskong Handog 2024, City Mayor's, Tabaco City under Contract ID No. 041-10-2024-GOODS-PB*; and
- b) To recommend to the City Mayor of Tabaco the award of contract to *FOODSPHERE, INC.* in the amount of *Sixteen Million Five Hundred Sixty-Seven Thousand Two Hundred Sixty Pesos (Php 16,567,260.00)*.


