BAC Resolution No. 2024-4Q-12- 1650

A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO 4KMB GENERAL MERCHANDISE FOR THE SUPPLY & DELIVERY OF VARIOUS PLASTIC BAGS FOR THE PRODUCTION OF COMPLEMENTARY FOODS IN TABACO F1K++ NUTRI CENTER CONTRACT ID NO. 040-10-2024-GOODS-PB-R2.

WHEREAS, the Local Government Unit of Tabaco City posted the Invitation to Bid for the *Supply & Delivery of Various Plastic Bags for the Production of Complementary Foods in Tabaco F1K++ Nutri Center under Contract ID No. 040-10-2024-GOODS-PB-R2*, with an Approved Budget for the Contract (ABC) amounting to *Six Hundred Seventy-Three Thousand Nine Hundred Eighty Pesos (Php 673,980.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, one (1) supplier had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission and opening of bids on December 04, 2024, the BAC received one (1) bid proposal;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary "pass/fail" criteria, resulted as follows, to wit:

WHEREAS, the BAC immediately conducted the detailed evaluation of bid, which resulted as follows, to wit:


