BAC Resolution No. 2024-4Q-12- 1660

A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO 4KMB GENERAL MERCHANDISE FOR THE SUPPLY & DELIVERY OF VARIOUS OFFICE SUPPLIES, GENERAL SERVICES OFFICE, TABACO CITY UNDER CONTRACT ID NO. 042-10-2024-GOODS-PB-R1.

WHEREAS, the Local Government Unit of Tabaco City posted the Invitation to Bid for the *Supply & Delivery of Various Office Supplies, General Services Office, Tabaco City under Contract ID No. 042-10-2024-GOODS-PB-R1*, with an Approved Budget for the Contract (ABC) amounting to *Two Million Eight Hundred Twenty-Three Thousand One Hundred Sixty-One Pesos and Fifteen Centavos (Php 2,823,161.15)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, one (1) supplier had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission and opening of bids on December 04, 2024, the BAC received one (1) bid proposal;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary “pass/fail” criteria, resulted as follows, to wit:

WHEREAS, the BAC immediately conducted the detailed evaluation of bid, which resulted as follows, to wit:



WHEREAS, the BAC Technical Working Group (TWG) conducted a post-qualification of **4KMB General Merchandise**, the bidder with single calculated bid, involving the verification and validation of its legal, technical and financial documents. It was found that **4KMB General Merchandise** is substantially compliant with the requirements of the foregoing procurement and its bid is responsive;

NOW, THEREFORE, for and in consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:


- a) To declare the bid of **4KMB General Merchandise** as the Single Calculated Responsive Bid (SCRB) for the *Supply & Delivery of Various Office Supplies, General Services Office, Tabaco City under Contract ID No. 042-10-2024-GOODS-PB-R1*; and
- b) To recommend to the City Mayor of Tabaco the award of contract to **4KMB General Merchandise** in the amount of *Two Million Eight Hundred Twenty-Two Thousand Two Hundred Twenty-Two Pesos and Twenty-Five Centavos (Php 2,822,222.25)*.




