A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO FIVE M HARDWARE AND CONSTRUCTION SUPPLY FOR THE SUPPLY & DELIVERY OF VARIOUS HARDWARE MATERIALS AND SUPPLIES FOR GSO MAINTENANCE

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Shopping under Section 52.1 (b)** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 24-09-1242** with an Approved Budget for the Contract (ABC) of **Php 475,755.00**;
