A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO ARIZAPA WELDING SHOP FOR THE JO-LABOR, MATERIALS AND EQUIPMENT FOR THE REPAIR AND REHABILITATION OF AGRICULTURE OFFICE AT BRGY. FATIMA, TABACO CITY
