A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO CAR ACCESS AUTO SUPPLY & GEN. MDSE. INC. FOR THE SUPPLY & DELIVERY OF PARTS AND ACCESSORIES FOR RESCUE VEHICLE WITH PLATE NO. SAB-6278, PATROL BOAT AND MOTORPOOL SUPPLIES
