BAC Resolution No. 2025-1Q-02- 0014

A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO BMT MARKETING FOR THE SUPPLY, DELIVERY & INSTALLATION OF LED WALL AND SMART TV, CDRRMO, TABACO CITY UNDER CONTRACT ID NO. 001-01-2025-GOODS-PB.

WHEREAS, the City Government of Tabaco posted the Invitation to Bid for the *Supply, Delivery, & Installation of LED Wall and Smart TV, CDRRMO, Tabaco City under Contract ID No. 001-01-2025-GOODS-PB*, with an Approved Budget for the Contract (ABC) amounting to *Two Million Pesos (Php 2,000,000.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, two (2) suppliers had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission and opening of bids on January 29, 2025, the BAC received two (2) bid proposals;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary “pass/fail” criteria, resulted as follows, to wit:

WHEREAS, the BAC immediately conducted the detailed evaluation of bid, which resulted as follows, to wit:



It was found that **BMT Marketing** is substantially compliant with the requirements of the foregoing procurement and its bid is responsive;



- a) To declare the bid of **BMT MARKETING** as the Single Calculated Responsive Bid (SCRB) for the *Supply, Delivery & Installation of LED Wall and Smart TV, CDRRMO, Tabaco City, Contract ID No. 001-01-2025-GOODS-PB*; and
- b) To recommend to the City Mayor of Tabaco the award of contract to **BMT MARKETING** in the amount of *One Million Nine Hundred Sixty-Three Thousand Pesos (Php 1,963,000.00)*.




