A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO JAC AUTOMOBILE INT'L. PHILS. INC FOR THE SUPPLY AND DELIVERY OF 1-UNIT BRAND NEW WHEEL TYPE BACKHOE-LOADER FOR CENTRAL MRF OPERATION AND MAINTENANCE, CITY MAYOR'S OFFICE, TABACO CITY UNDER CONTRACT ID NO. 003-01-2025-GOODS-PB.

WHEREAS, the City Government of Tabaco posted the Invitation to Bid for the *Supply and Delivery of 1-Unit Brand New Wheel Type Backhoe-Loader for Central MRF Operation and Maintenance, City Mayor's Office, Tabaco City under Contract ID No. 003-01-2025-GOODS-PB*, with an Approved Budget for the Contract (ABC) amounting to *Five Million Pesos (Php 5,000,000.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, one (1) supplier had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission and opening of bids on February 05, 2025, the BAC received one (1) bid proposal;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary "pass/fail" criteria, resulted as follows, to wit:

WHEREAS, the BAC immediately conducted the detailed evaluation of bid, which resulted as follows, to wit:


