A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO ALLEN TRADING FOR THE SUPPLY, DELIVERY & INSTALLATION OF SIREN WITH CONTROLLER, CDRRMO, TABACO CITY UNDER CONTRACT ID NO. 054-12-2024-GOODS-PB

WHEREAS, the Local Government Unit of Tabaco City posted the Invitation to Bid for the *Supply, Delivery & Installation of Siren with Controller, CDRRMO, Tabaco City under Contract ID No. 054-12-2024-GOODS-PB* with an Approved Budget for the Contract (ABC) amounting to *One Million Pesos (Php 1,000,000.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, one (1) supplier had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission and opening of bids on December 27, 2024, the BAC received one (1) bid proposal;

WHEREAS, the opening and preliminary examination of bid, using non-discretionary “pass/fail” criteria, resulted as follows, to wit:

WHEREAS, the BAC immediately conducted the detailed evaluation of bid, which resulted as follows, to wit:







- b) To recommend to the City Mayor of Tabaco the award of contract to *ALLEN TRADING* in the amount of *Six Hundred Ninety-Five Thousand Pesos (Php 695,000.00)*.




