**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO FIVE M HARDWARE AND CONSTRUCTION SUPPLY FOR THE SUPPLY & DELIVERY OF VARIOUS HARDWARE SUPPLIES FOR GSO AIRCON MAINTENANCE**

**WHEREAS**, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 25-02-0033** with an Approved Budget for the Contract (ABC) of **Php 256,392.00**;
