A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO MGM MEDICAL SUPPLIES & GENERAL MERCHANDISE FOR THE SUPPLY & DELIVERY MULTIVITAMINS FOR PERMANENT, CASUAL, COS AND JOB ORDER EMPLOYEES
