A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO 3GX COMPUTER & IT SOLUTIONS TECHNOSHOP FOR THE SUPPLY & DELIVERY OF VARIOUS IT SUPPLIES FOR THE OPERATIONALIZATION OF NUTRITION OFFICE AND TABACO F1K++ NUTRI CENTER

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Shopping under Section 52.1 (b)** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 25-03-0420** with an Approved Budget for the Contract (ABC) of **Php 71,780.50**;
