

Contract Agreement Form

THIS AGREEMENT made the MAR 15 2019 day of 2019 between *City Government of Tabaco City*, Philippines (hereinafter called "the Entity") of the one part and *MEIN INTERIOR CONCEPTS*, Unit 206, LSS Bldg. Tirona Highway Habay II, Bacoor, Cavite (hereinafter called "the Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., *Supply, Delivery & Installation of Furniture & Fixtures, 3rd Flr. Tabaco City Hall Annex Building, Tabaco City under Contract ID No. 001-01-2019-GOODS* and has accepted the Bid of the Supplier for the supply of those goods and services in the sum of *Two Million Nine Hundred Seventy-Nine Thousand One Hundred Fifty-One Pesos and Two Centavos (Php 2,979,151.02)* (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - (a) the Supplier's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted (e.g. bidder's response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity's bid evaluation;
 - (b) the Schedule of Requirements;
 - (c) the Technical Specifications;
 - (d) the General Conditions of Contract;
 - (e) the Special Conditions of Contract;
 - (f) the Performance Security; and
 - (g) the Entity's Notice of Award.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the *Supply, Delivery & Installation of Furniture & Fixtures at the 3rd Flr. Tabaco City Hall Annex Building, Tabaco City* as described in the hereto attached Purchase Order within **sixty (60) calendar days from receipt of the Notice to Proceed**, delivered at the **City Government of Tabaco** and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.


