A RESOLUTION DECLARING THE LOWEST CALCULATED RESPONSIVE BIDDER (LCRB) AND RECOMMENDING THE AWARD OF CONTRACT FOR THE SUPPLY OF LABOR, MATERIALS & EQUIPMENT FOR THE REPAIR/ REHABILITATION OF BONGON HALL & LAGMAN GYMNASIUM, TNHS COMPOUND, BANGKILINGAN, TABACO CITY UNDER CONTRACT ID NO. 009-05-2019-INFRA.

WHEREAS, the Local Government Unit of Tabaco City posted an Invitation to Bid for the **Supply of Labor, Materials and Equipment for the Repair/Rehabilitation of Bongon Hall & Lagman Gymnasium, TNHS Compound, Bangkilingan, Tabaco City under Contract ID No. 009-05-2019-INFRA** with an **Approved Budget for the Contract (ABC)** amounting to **Php 4,995,275.76** in the PhilGEPS website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to said posting fifteen (15) prospective bidders had purchased the bidding documents;

WHEREAS, however, only twelve (12) participating bidders was able to submit their bids before the deadline for bid submission on June 03, 2019;

WHEREAS, upon opening and preliminary examination of bids on June 03, 2019, only nine (9) participating bidders were rated “passed”, to wit:

WHEREAS, per post-qualification conducted by the Technical Working Group (TWG) of the bidder with the Lowest Calculated Bid (LCB), Omega Construction & Supply was found to be non-compliant

with the requirements set in the Bidding Documents and was, therefore, declared post-disqualified for the foregoing project as per BAC Resolution No. 2019-2Q-06-0146, dated June 18, 2019;

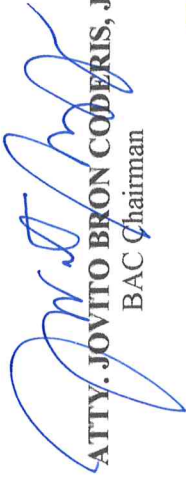
WHEREAS, the BAC through its Technical Working Group (TWG) proceeded with the post-qualification of the bidder with next lowest calculated bid, QDC Construction and Supply;

WHEREAS, per post-qualification of the TWG, QDC Construction and Supply was found to be compliant and responsive with the requirements of the project and was therefore recommended for the award of the contract;

NOW THEREFORE, for and in consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

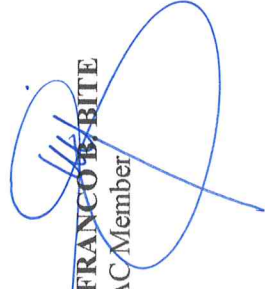
- a) To declare **QDC Construction & Supply** as the bidder with the Lowest Calculated Responsive Bid (LCRB) for the foregoing project;
- b) To recommend to the City Mayor of Tabaco the award of contract to **QDC Construction & Supply** in the amount of **Four Million Nine Hundred Thirty-Seven Thousand One Hundred Sixty Pesos and Eighty-Nine Centavos (Php 4,937,160.89)**
