## **CONTRACT AGREEMENT**

THIS AGREEMENT, made this <u>22</u> day of *July 2021* between the *CITY GOVERNMENT OF TABACO* (hereinafter called "the Entity") of the one part and *MEDICATUS PHARMA DISTRIBUTOR*, 396 Washington St., Binatagan (Pob.), Ligao City (hereinafter called "the Supplier") of the other part;

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

    - i. Schedule of Requirements;
    - ii. Technical Specifications;
    - iii. General and Special Conditions of Contract; and
    - iv. Supplemental or Bid Bulletins, if any
  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration for the sum of Seven Hundred Sixty-Two Thousand One Hundred Three Pesos and Sixty-Five Centavos (Php 762,103.65) or such other sums as may be ascertained, Medicatus Pharma Distributor agrees to supply and deliver various Drugs and Medicines at Fatima Wellness K-linik, Tabaco City in accordance with his/her/its Bid.
- 4. The *City Government of Tabaco* agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
