**A RESOLUTION DECLARING FAILURE OF BIDDING FOR THE SUPPLY & DELIVERY OF 70 UNITS ANDROID TABLET FOR CBMS CENSUS 2022, CBMS OFFICE, TABACO CITY UNDER CONTRACT ID NO. 003-05-2022-GOODS.**

WHEREAS, the Local Government Unit of Tabaco City posted the Invitation to Bid for the *Supply & Delivery of 70 Units Android Tablet for CBMS Census 2022, CBMS Office, Tabaco City under Contract ID No. 003-05-2022-GOODS* with an Approved Budget for the Contract amounting to *One Million Forty-Nine Thousand Three Hundred Pesos (Php 1,049,300.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, prior to the deadline for the bid submission and opening on May 23, 2022, the BAC received only one (1) bid, from Pixel 8 Web Solutions & Consultancy, Inc.;


WHEREAS, upon opening of its bid, the BAC found that the Technical and Financial Component was enclosed in one envelope only and not separately sealed as what is required in Section 25.1 of the IRR of RA 9184;

WHEREAS, the BAC declared the bid of the sole participating bidder Pixel 8 Web Solutions & Consultancy, Inc. "failed" for non-compliance with the requirements of the project;

WHEREAS, Section 35.1(c) of the 2016 Revised IRR-RA9184 provides that the BAC shall declare failure of bidding when all bids fail to comply with all the bid requirements;

NOW THEREFORE, for and in consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED to declare **FAILURE OF BIDDING** for the *Supply & Delivery of 70 Units Android Tablet for CBMS Census 2022, CBMS Office, Tabaco City under Contract ID No. 003-05-2022-GOODS*.
