### **BAC Resolution No. 2022-4Q-11-0927**

**RECOMMENDING THE AWARD OF CONTRACT TO THE BICOL REGIONAL WEEKLY DIGEST FOR THE PUBLICATION OF CITY ORDINANCE NO. 074-2022, REVISING THE ZONING REGULATIONS OF THE CITY OF TABACO AND PROVINCE FOR THE ADMINISTRATION, ENFORCEMENT, AND AMENDMENT THEREOF AND FOR THE REPEAL OF ALL ORDINANCES IN CONFLICT THEREWITH**

**WHEREAS**, on September 28, 2022, the Office of the SP Secretariat has submitted to the Bids and Awards Committee (BAC) **Purchase Request No. 22-09-1005** requesting the procurement of services for the “**Publication of City Ordinance No. 074-2022, Revising the Zoning Regulations of the City of Tabaco and Province for the Administration, Enforcement, and Amendment Thereof and for the Repeal of all Ordinances In Conflict Therewith**” with an Approved Budget for the Contract (ABC) in the amount of **Seven Million Eight Hundred Ninety Thousand Pesos (Php 7,890,000.00)** sourced from the General Fund 2022;

**WHEREAS**, along with the purchase request is the **Market Study** of the End-User on the probable supplier/ source for the procurement of the publication services;

**WHEREAS**, the RA 7160 or the Local Government Code of the Philippines, particularly Sections 59 and 511 thereof, mandates the publication of ordinances with penal sanctions in a newspaper of general circulation within the province where the local legislative body concerned belongs, or within the territorial jurisdiction of the local government unit concerned;

**WHEREAS**, the Market Study determined that **The Bicol Regional Weekly Digest** is one of the news publisher with the highest number of government publication contracts in the Province of Albay where the City Government of Tabaco belongs to. The Study also showed that said publisher offers the most advantageous price for the Government;

**WHEREAS**, it was ascertained that it would be more advantageous for the government to negotiate said publication service with The Bicol Regional Weekly Digest by resorting to **Negotiated Procurement (Media Services)** under Sec. 53.6 of the IRR-RA 9184;

**WHEREAS**, upon approval of the HOPE of the use of alternative mode of procurement, the BAC initiated the procurement activity by inviting The Bicol Regional Weekly Digest to submit its Price Quotation not later than 9:00 AM on October 25, 2022;


**WHEREAS**, The Bicol Regional Weekly Digest has submitted its Price Quotation before the lapse of the deadline of its submission;

**WHEREAS**, The Bicol Regional Weekly Digest has offered to provide the required publication services at a contract price amounting to **Seven Million Six Hundred Thousand Sixty-Eight Pesos (Php 7,600,068.00)**;

**WHEREAS**, upon careful review and evaluation of its legal, technical, and financial requirements for the project, the Technical Working Group (TWG) has recommended the award of the contract to **The Bicol Regional Weekly Digest** in accordance with Section 53.6 of the 2016 Revised IRR-RA9184 and the Consolidated Guidelines for the Alternative Methods of Procurement;


**NOW, THEREFORE**, in the light of the foregoing considerations, We, the members of the Bids and Award Committee, hereby **RESOLVE**, as it is hereby **RESOLVED** to recommend for approval by the City Mayor, **CIELO KRISSEL LAGMAN-LUISTRO**, the award of the foregoing contract to **The Bicol Regional Weekly Digest** at a contract price amounting to **Seven Million Six Hundred Thousand Sixty-Eight Pesos (Php 7,600,068.00)**;


