BAC Resolution No. 2022-3Q-08- 0579

A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO SCUDERIA ENTERPRISES FOR THE SUPPLY & DELIVERY OF ONE UNIT BRAND NEW GARBAGE TRUCK (COMPACTOR TYPE), CENRO, TABACO CITY UNDER CONTRACT ID NO. 006-06-2022-GOODS.

WHEREAS, the Local Government Unit of Tabaco City posted the Invitation to Bid for the *Supply & Delivery of One Unit Brand New Garbage Truck (Compactor Type), CENRO, Tabaco City under Contract ID No. 006-06-2022-GOODS*, with an Approved Budget for the Contract (ABC) amounting to *Five Million Pesos (Php 5,000,000.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, two (2) suppliers had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission and opening of bids on July 04, 2022, the BAC received two (2) bid proposal from Kingling Isuzu Philippines, Inc., and Scuderia Enterprises;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary “pass/fail” criteria, resulted as follows, to wit:

Kingling Isuzu Philippines, Inc. was disqualified for non-compliance with the requirements under the Technical Component.

WHEREAS, the BAC immediately conducted the detailed evaluation of bid, which resulted to the following, to wit:

WHEREAS, the BAC Technical Working Group (TWG) conducted a post-qualification of *Scuderia Enterprises*, the bidder with single calculated bid, which involves the verification and validation of its legal, technical and financial documents and the inspection of the unit offered. It was found that *Scuderia Enterprises* is substantially compliant with the requirements of the foregoing procurement and its bid is responsive;

NOW, THEREFORE, for and in consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To declare the bid of *SCUDERIA ENTERPRISES* as the Single Calculated Responsive Bid (SCRB) for the *Supply & Delivery of One Unit Brand New Garbage Truck (Compactor Type), CENRO, Tabaco City under Contract ID No. 006-06-2022-GOODS*; and
- b) To recommend to the City Mayor of Tabaco the award of contract to *SCUDERIA ENTERPRISES* in the amount of *Four Million Nine Hundred Eighty-Eight Thousand Pesos (Php 4,988,000.00)*.
