A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO P & J AGRICULTURAL TRADING, INC. FOR THE SUPPLY & DELIVERY OF INACTIVATED RABIES VIRUS VACCINE, CITY AGRICULTURE OFFICE, TABACO CITY UNDER CONTRACT ID NO.010-07-2022-GOODS.

WHEREAS, the Local Government Unit of Tabaco City posted the Invitation to Bid for the Supply & Delivery of Inactivated Rabies Virus Vaccine, City Agriculture Office, Tabaco City under Contract ID No.010-07-2022-GOODS with an Approved Budget for the Contract (ABC) amounting to One Million Pesos (Php 1,000,000.00) in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, one (1) supplier had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission and opening of bids on August 18, 2022, the BAC received only one (1) bid proposal;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary "pass/fail" criteria, resulted as follows, to wit:

WHEREAS, the BAC immediately conducted the detailed evaluation of bid, which resulted to the following, to wit:

WHEREAS, the BAC Technical Working Group (TWG) conducted a post-qualification of P & J Agricultural Trading, Inc., the bidder with single calculated bid, which involves the verification and validation of its legal, technical and financial documents. It was found that P & J Agricultural Trading, Inc. is substantially compliant with the requirements of the foregoing procurement and its bid is responsive;

NOW, THEREFORE, for and in consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To declare the bid of *P & J AGRICULTURAL TRADING*, *INC*. as the Single Calculated Responsive Bid (SCRB) for the *Supply & Delivery of Inactivated Rabies Virus Vaccine*, *City Agriculture Office*, *Tabaco City under Contract ID No.010-07-2022-GOODS*.
- b) To recommend to the City Mayor of Tabaco the award of contract to *P & J Agricultural Trading*, *Inc.* in the amount of *Nine Hundred Ninety-Six Thousand Pesos (Php 996,000.00)*.
