BAC Resolution No. 2022-3Q-08- 0624

A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO BCVR PRIME ENTERPRISE FOR THE SUPPLY & DELIVERY OF DRUGS & MEDICINES, FATIMA WELLNESS K-LINIK, TABACO CITY UNDER CONTRACT ID NO. 014-08-2022-GOODS

WHEREAS, the Local Government Unit of Tabaco City posted the Invitation to Bid for the *Supply & Delivery of Drugs & Medicines, Fatima Wellness K-Linik, Tabaco City under Contract ID No. 014-08-2022-GOODS*, with an Approved Budget for the Contract (ABC) amounting to *Seven Hundred Forty-Four Thousand Four Hundred Sixty-Seven Pesos and Forty-Six Centavos (Php 744,467.46)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, one supplier has shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission and opening of bids on August 16, 2022, the BAC received only one (1) bid proposal;

WHEREAS, the opening and preliminary examination of bid, using non-discretionary “pass/fail” criteria, resulted as follows, to wit:

WHEREAS, the BAC immediately conducted the detailed evaluation of bid, which resulted to the following, to wit:



WHEREAS, the BAC Technical Working Group (TWG) conducted a post-qualification of *BCVR Prime Enterprise*, the bidder with single calculated bid, which involves the verification and validation of its legal, technical and financial documents. It was found that *BCVR Prime Enterprise* is substantially compliant with the requirements of the foregoing procurement and its bid is responsive;

NOW, THEREFORE, for and in consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To declare the bid of *BCVR PRIME ENTERPRISE* as the Single Calculated Responsive Bid (SCRB) for the *Supply & Delivery of Drugs & Medicines, Fatima Wellness K-Linik, Tabaco City under Contract ID No. 014-08-2022-GOODS*; and
- b) To recommend to the City Mayor of Tabaco the award of contract to *BCVR PRIME ENTERPRISE* in the amount of *Six Hundred Eighty-Seven Thousand Nine Hundred Eighty-One Pesos and Fifty Centavos (Php 687,981.50)*.
