### A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO MER ELECTRICAL INSTALLATION SERVICES FOR THE JO-SUPPLY, LABOR & MATERIALS FOR POWER SUPPLY SYSTEM AT WASTE WATER TREATMENT FACILITY, SAN VICENTE, TABACO CITY

**WHEREAS**, after the deadline for submission of price quotations, the return of RFQs sent resulted to the following Price Quotations:


