BAC Resolution No. 2022-3Q-09-0632

A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO ROMARC ENTERPRISES FOR THE SUPPLY & DELIVERY OF BIO N FERTILIZER FOR DISTRIBUTION TO FARMERS, CITY AGRICULTURE OFFICE, TABACO CITY UNDER CONTRACT ID NO. 011-07-2022-GOODS.

WHEREAS, the Local Government Unit of Tabaco City posted the Invitation to Bid for the *Supply & Delivery Bio N Fertilizer for Distribution to Farmers, City Agriculture Office, Tabaco City under Contract ID No. 011-07-2022-GOODS* with an Approved Budget for the Contract (ABC) amounting to *One Million Three Hundred Twenty Thousand Pesos (Php 1,320,000.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, one (1) supplier had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission and opening of bids on August 18, 2022, the BAC received only one (1) bid proposal;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary “pass/fail” criteria, resulted as follows, to wit:

WHEREAS, the BAC Technical Working Group (TWG) conducted a post-qualification of *ROMARC Enterprises* the bidder with single calculated bid, which involves the verification and validation of its legal, technical and financial documents. It was found that *ROMARC Enterprises* is substantially compliant with the requirements of the foregoing procurement and its bid is responsive;


NOW, THEREFORE, for and in consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To declare the bid of *ROMARC ENTERPRISES* as the Single Calculated Responsive Bid (SCRB) for the *Supply & Delivery of Bio N Fertilizer for Distribution to Farmers, City Agriculture Office, Tabaco City under Contract ID No. 011-07-2022-GOODS*,
- b) To recommend to the City Mayor of Tabaco the award of contract to *ROMARC Enterprises* in the amount of *Nine Hundred Sixty-Eight Thousand Pesos (Php 968,000.00)*.
