BAC Resolution No. 2022-3Q-09-0673

A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO ALBAY COMPUTER & ELECTRONICS SUPPLIES & REPAIR FOR THE SUPPLY & DELIVERY OF I.T. EQUIPMENT, DEPED-SDO, TABACO CITY UNDER CONTRACT ID NO.017-08-2022-GOODS.

WHEREAS, the Local Government Unit of Tabaco City posted the Invitation to Bid for the *Supply & Delivery of IT Equipment, DepEd-SDO, Tabaco City under Contract ID No. 017-08-2022-GOODS*, with an Approved Budget for the Contract (ABC) amounting to *One Million Nine Hundred Seventy-Seven Thousand Pesos (Php 1,977,000.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, one (1) supplier had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission and opening of bids on August 30, 2022, the BAC received only one (1) bid proposal;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary "pass/fail" criteria, resulted as follows, to wit:

WHEREAS, the BAC immediately conducted the detailed evaluation of bid, which resulted to the following, to wit:



WHEREAS, the BAC Technical Working Group (TWG) conducted a post-qualification of *Albay Computer & Electronics Supplies & Repair*, the bidder with single calculated bid, which involves the verification and validation of its legal, technical and financial documents. It was found that *Albay Computer & Electronics Supplies & Repair* is substantially compliant with the requirements of the foregoing procurement and its bid is responsive;

NOW, THEREFORE, for and in consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To declare the bid of **ALBAY COMPUTER & ELECTRONICS SUPPLIES AND REPAIR** as the Single Calculated Responsive Bid (SCRB) for the *Supply & Delivery of IT Equipment, DepEd-SDO, Tabaco City under Contract ID No. 017-08-2022-GOODS*.
- b) To recommend to the City Mayor of Tabaco the award of contract to *Albay Computer & Electronics Supplies and Repair* in the amount of *One Million Five Hundred Seventy-Six Thousand Twenty-Five Pesos (Php 1,576,025.00)*,
