A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO C.B. THATTALIL ENTERPRISE FOR THE SUPPLY & DELIVERY OF FOOD PROCESSING EQUIPMENT, CITY NUTRITION OFFICE, TABACO CITY (REBID) UNDER CONTRACT ID NO. 012-07-2022-GOODS

WHEREAS, the Local Government Unit of Tabaco City through its Bids and Awards Committee (BAC) posted the Invitation to Bid for the *Supply & Delivery of Food Processing Equipment, City Nutrition Office, Tabaco City (Rebid) under Contract ID No. 012-07-2022-GOODS* with an Approved Budget for the Contract (ABC) amounting to *One Million Four Hundred Seventy-Seven Thousand Five Hundred Pesos (Php 1,477,500.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, one (1) supplier had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission and opening of bids on October 10, 2022, the BAC received only one (1) bid proposal;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary "pass/fail" criteria, resulted as follows, to wit:

WHEREAS, the BAC immediately conducted the detailed evaluation of bid, which resulted to the following, to wit:





NOW, THEREFORE, for and in consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To declare the bid of *C.B. THATTALIL ENTERPRISE* as the Single Calculated Responsive Bid (SCRB) for the *Supply & Delivery of Food Processing Equipment, City Nutrition Office, Tabaco City (Rebid) under Contract ID No.012-07-2022-GOODS*.
- b) To recommend to the City Mayor of Tabaco the award of contract to *C.B. Thattalil Enterprise* in the amount of *One Million Four Hundred Eighteen Thousand Five Hundred Pesos (Php 1,418,500.00)*




