BAC Resolution No. 2022-4Q-10-0919

A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO NUTRIDENSE FOOD MANUFACTURING CORP. FOR THE SUPPLY & DELIVERY OF RICE-MONGO (RIMO) FOR FEEDING SUPPLEMENTATION OF 6-23 MONTHS OLD CHILDREN, CITY NUTRITION OFFICE, TABACO CITY (REBID) UNDER CONTRACT ID NO. 018-08-2022-GOODS

WHEREAS, the Local Government Unit of Tabaco City posted the Invitation to Bid for the *Supply & Delivery of Rice-Mongo (RIMO) for Feeding Supplementation of 6-23 Months Old Children, City Nutrition Office, Tabaco City (Rebid) under Contract ID No. 018-08-2022-GOODS*, with an Approved Budget for the Contract (ABC) amounting to *Six Million Eight Hundred Seventy-Six Thousand Pesos (Php 6,876,000.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, one supplier has shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission and opening of bids on October 10, 2022, the BAC received only one (1) bid proposal;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary "pass/fail" criteria, resulted as follows, to wit:

WHEREAS, the BAC immediately conducted the detailed evaluation of bid, which resulted to the following, to wit:




WHEREAS, the BAC Technical Working Group (TWG) conducted a post-qualification of *Nutridense Food Manufacturing Corp.*, the bidder with single calculated bid, which involves the verification and validation of its legal, technical and financial documents. It was found that *Nutridense Food Manufacturing Corp.* is substantially compliant with the requirements of the foregoing procurement and its bid is responsive;

NOW, THEREFORE, for and in consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To declare the bid of *NUTRIDENSE FOOD MANUFACTURING CORP.* as the Single Calculated Responsive Bid (SCRB) for the *Supply & Delivery of Rice-Mongo (RIMO) for Feeding Supplementation of 6-23 Months Old Children, City Nutrition Office, Tabaco City (Rebid) under Contract ID No. 018-08-2022-GOODS*; and
- b) To recommend to the City Mayor of Tabaco the award of contract to *NUTRIDENSE FOOD MANUFACTURING CORP.* in the amount of *Six Million Eight Hundred Seventy-Four Thousand Four Hundred Forty Pesos (Php 6,874,440.00)*.




