BAC Resolution No. 2022-4Q-11-0928

A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO EDUARDO J. ALUZAN AGRI-MARINE PRODUCTS DEALER FOR THE SUPPLY & DELIVERY OF CERTIFIED ORGANIC SOIL AMENDMENTS (REBID), CITY AGRICULTURE OFFICE, TABACO CITY UNDER CONTRACT ID NO. 019-08-2022-GOODS.

WHEREAS, the Local Government Unit of Tabaco City posted the Invitation to Bid for the *Supply & Delivery of Certified Organic Soil Amendments, City Agriculture Office, Tabaco City (Rebid) under Contract ID No. 019-08-2022-GOODS* with an Approved Budget for the Contract (ABC) amounting to *One Million Two Hundred Forty-Nine Thousand Nine Hundred Fifty Pesos (Php 1,249,950.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, one (1) supplier had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission and opening of bids on October 13, 2022, the BAC received one (1) bid proposal;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary "pass/fail" criteria, resulted as follows, to wit:

WHEREAS, the BAC immediately conducted the detailed evaluation of bid, which resulted to the following, to wit:





It was found that *Eduardo J. Aluzan Agri-Marine Products Dealer* is substantially compliant with the requirements of the foregoing procurement and its bid is responsive;

NOW, THEREFORE, for and in consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To declare the bid of *EDUARDO J. ALUZAN AGRI-MARINE PRODUCTS DEALER* as the Single Calculated Responsive Bid (SCRB) for the *Supply & Delivery of Certified Organic Soil Amendments, City Agriculture Office, Tabaco City (Rebid) under Contract ID No. 019-08-2022-GOODS*.
- b) To recommend to the City Mayor of Tabaco the award of contract to *Eduardo J. Aluzan Agri-Marine Products Dealer* in the amount of *One Million Two Hundred Thirty Thousand Six Hundred Twenty-Three Pesos and Eighty-Five Centavos (Php 1,230,623.85)*.




