### BAC Resolution No. 2022-4Q-10- 0823

**A RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO LEGAZPI PREMIUM DEVELOPMENT CORPORATION FOR THE CONSTRUCTION/REHABILITATION OF VARIOUS INFRASTRUCTURE PROJECTS (WATER SYSTEM/STREETLIGHTS/POWER SUPPLY), VARIOUS BARANGAYS, TABACO CITY UNDER CONTRACT ID NO. 022-09-2022-INFRA**

**WHEREAS**, the Local Government Unit of Tabaco City posted the Invitation to Bid for the *Construction/Rehabilitation of Various Infrastructure Projects (Water System/Streetlights/Power Supply), Various Barangays, Tabaco City under Contract ID No. 022-09-2022-INFRA*, with an Approved Budget for the Contract (ABC) amounting to *Thirty-Seven Million Nine Hundred Thousand Pesos (Php 37,900,000.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

**WHEREAS**, in response to the said posting, five (5) contractors had shown interest to participate by purchasing the bidding documents;

**WHEREAS**, during the deadline for submission and opening of bids on September 28, 2022, the BAC received four (4) bids;

**WHEREAS**, the opening and preliminary examination of bids, using non-discretionary “pass/fail” criteria, resulted as follows, to wit:

The other bidders, Kael Construction and Supply, A.G. Araja Construction and Development Corporation, and Norsophil Metal Resources Inc. received failed ratings in their Technical Components for non-compliance with the requirements of the Project.

**WHEREAS**, the BAC immediately conducted the detailed evaluation of bid which resulted to the following, to wit:


**WHEREAS**, per post-qualification conducted by the BAC Technical Working Group (TWG) involving the verification and validation of legal, technical and financial documents of the bidder with single calculated bid, *Legazpi Premium Development Corporation* was found to be substantially compliant with the requirements of the said procurement and its bid has been found to be responsive;


**NOW THEREFORE**, for and in consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To declare the bid of *Legazpi Premium Development Corporation* as the Single Calculated Responsive Bid (SCRB) for the *Construction/Rehabilitation of Various Infrastructure Projects (Water System/Streetlights/Power Supply), Various Barangays, Tabaco City under Contract ID No. 022-09-2022-INFRA*; and


- b) To recommend to the City Mayor of Tabaco the award of contract to *Legazpi Premium Development Corporation* in the amount of *Thirty-Six Million Seven Hundred Sixty-Three Thousand Pesos and Sixty-Two Centavos (Php 36,763,000.62)*.


