A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO GLAMIEL PHARMA AND MEDICAL SUPPLIES TRADING FOR THE SUPPLY & DELIVERY OF MOBILE STADIOMETER FOR MEASURING HEIGHT FOR NUTRITION ADVOCACY PROGRAM 2022

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Shopping under Section 52.1 (b)** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 22-08-0765** with an Approved Budget for the Contract (ABC) of **Php 595,000.00**;

WHEREAS, the BAC has posted in the PhilGEPS website the Request for Quotation for this procurement and sent the same to bonafide suppliers, indicating the specifications, quantity, ABC and the terms and conditions of the items to be procured;

WHEREAS, after the deadline for submission of price quotations, the BAC received three (3) price quotations from suppliers, namely Mariken Weida Corporation, Glamiel Pharma and Medical Supplies Trading, Wellness Pro Inc.;

WHEREAS, the opening of price quotations resulted as follows:

WHEREAS, upon careful examination, validation and verification of all the documents submitted by the supplier with the lowest quoted price, Mariken Weida Corporation was found to be non-compliant with the minimum technical specification of the project. Hence, its bid was disqualified.

WHEREAS, the BAC proceeded with the examination, validation, and verification of all the documents submitted by the supplier with the second lowest quoted price, Glamiel Pharma and Medical Supplies Trading, and it was found to be responsive with the requirements of the project.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) To award the contract to **GLAMIEL PHARMA AND MEDICAL SUPPLIES TRADING** as the Supplier with the Lowest Calculated and Responsive Bid (LCRB) for this procurement.
- b) To recommend to the City Mayor of Tabaco the award of contract to **GLAMIEL PHARMA AND MEDICAL SUPPLIES TRADING** in the amount of **Five Hundred Seventy-Eight Thousand Pesos (Php 578,000.00)**.
