A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO TABACO SANTIAGO TRADING INC. FOR THE JO-LABOR AND MATERIALS-CONSTRUCTION MATERIALS AND SUPPLIES FOR THE IMPROVEMENT OF TEMPORARY MARKET OFFICE AT DIVINO ROSTRO, TABACO CITY

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 22-09-0949** with an Approved Budget for the Contract (ABC) of **Php 184,260.00**;
