A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO POWER PRIME CAR SERVICE CENTER FOR THE SUPPLY & DELIVERY OF VARIOUS VEHICLE TIRE AND LUBRICANTS FOR THE MOTOR VEHICLE WITH PLATE NO./CONDUCTION STICKER SJX-677 AND, SKL-994 OF GSO

WHEREAS, after the deadline for submission of price quotations, the return of RFQs sent resulted to the following Price Quotations:


