**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO MMC MARKETING FOR THE SUPPLY & DELIVERY OF MACHINE TOOLS FOR MAINTENANCE AND MOTORPOOL DIVISION**
