### A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO SIX G ENTERPRISES FOR THE SUPPLY & DELIVERY OF CONSTRUCTION MATERIALS AND SUPPLIES FOR THE FABRICATION AND INSTALLATION OF FENCE AND PLATFORM OF WATER LEVEL MONITORING SYSTEM AND AUTOMATIC RAIN GAUGE
