A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO JVJ APPLIANCE TRADING FOR THE SUPPLY & DELIVERY OF SPLIT TYPE WALL MOUNTED AIRCONDITIONING
