BAC Resolution No. 2022-4Q-1Q- 0886

A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO PHILIPPINE DUPLICATORS INC. FOR THE SUPPLY & DELIVERY OF DIGITAL COPIER

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Shopping under Section 52.1 (b)** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 22-10-1076** with an Approved Budget for the Contract (ABC) of **Php 80,000.00**;

WHEREAS, the BAC has posted in the PhilGEPS website the Request for Quotation for this procurement and sent the same to bonafide suppliers, indicating the specifications, quantity, ABC and the terms and conditions of the items to be procured;

WHEREAS, after the deadline for submission of price quotations, the BAC received four (4) price quotations from suppliers, namely Philcopy Corporation, Philippine Duplicators Inc., Legazpi General Merchandise, & F.E. LEE Enterprises;

WHEREAS, the opening of price quotations resulted as follows:

WHEREAS, upon careful examination, validation and verification of all the documents submitted by the supplier with the lowest quoted price, Philcopy Corporation was found to be non-compliant with the minimum technical specification of the project. Hence, its bid was disqualified.

WHEREAS, the BAC proceeded with the examination, validation, and verification of all the documents submitted by the supplier with the second lowest quoted price, Philippine Duplicators Inc., and it was found to be responsive with the requirements of the project.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) To award the contract to **PHILIPPINE DUPLICATORS INC.** as the Supplier with the Lowest Calculated and Responsive Bid (LCRB) for this procurement.
- b) To recommend to the City Mayor of Tabaco the award of contract to **PHILIPPINE DUPLICATORS INC.** in the amount of **Seventy-Nine Thousand Eight Hundred Pesos (Php 79,800.00)**.
