### A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO LIFERICH CONSOLIDATED CORPORATION FOR THE MEALS AND VENUE FOR THE STRENGTHENING GAD FOCAL POINT SYSTEM OF TABACO CITY

**WHEREAS**, after the deadline for submission of price quotations, the return of RFQs sent resulted to the following Price Quotations:


