**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO MMC MARKETING FOR THE SUPPLY & DELIVERY OF HARDWARE MATERIALS AND SUPPLIES FOR THE INSTALLATION/FABRICATION OF CHRISTMAS DECORATIONS (CANDY LAND THEMED CHRISTMAS IN TABACO CITY 2022)**
