#### A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO ASTRIDAIMOND CATERING SERVICES FOR THE MEALS AND VENUE FOR THE TRAINING OF TRAINERS ON FARM BUSINESS SCHOOL (FBS) UNDER HIGH VALUE CROPS DEVELOPMENT PROGRAM
