A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO BRIGHTKEY DEVELOPMENT AND CONSTRUCTION FOR THE SUPPLY & DELIVERY OF VARIOUS TOOLS FOR CENTRAL MRF AND SANITARY LANDFILL OPERATION, MAINTENANCE AND PPE'S OF THE PERSONNEL

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Shopping under Section 52.1 (b)** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 22-10-1135** with an Approved Budget for the Contract (ABC) of **Php 54,250.00**;

WHEREAS, the BAC has posted in the PhilGEPS website the Request for Quotation for this procurement and sent the same to bonafide suppliers, indicating the specifications, quantity, ABC and the terms and conditions of the items to be procured;
