A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO JADIEM SCHOOL & OFFICE SUPPLIES DEPOT FOR THE SUPPLY & DELIVERY OF OFFICE SUPPLIES
