#### A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO B & C ELECTROMECH FOR THE SUPPLY & DELIVERY OF PNEUMATIC TIRE FOR THE SPARE TIRES FOR R140W-9S HYUNDAI BACKHOE

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 22-10-1192** with an Approved Budget for the Contract (ABC) of **Php 594,269.44**;
